Special Educational Needs and Disability Policy

This policy should be read in conjunction with Chalk Ridge Primary School's SEND Information Report which can be found on the school website.

Compliance

At Chalk Ridge Primary School, we believe that, as far as possible, every child should have access to the full curriculum. We strive for 'high quality first teaching' and believe that every teacher is a teacher of every child, including those with Special Educational Needs or Disabilities (SEND).

Definition and Identification of SEND

As stated in the SEND Code of Practice, a child or young person has SEND if they have a learning difficulty or disability which calls for special educational provision to be made for them. A child of compulsory school age or a young person has a learning difficulty or disability if they:

- has a significantly greater difficulty in learning than the majority of others of the same age;
- has a disability which prevents or hinders them from making use of facilities of a kind generally provided for others of the same age in mainstream schools or mainstream post-16 institutions.

Speical Educational Needs and Disability Co-Ordinator (SENDCO)

Aims

At Chalk Ridge Primary School all pupils, regardless of their particular needs, are provided with inclusive teaching which will enable them to make the best possible progress. In school we will work hard to make them feel a valued member of the community.

- We aim to have a curriculum that is accessible to and inclusive of ALL pupils, and which meets their needs
- We aim to identify and assess the pupil's needs, at the earliest stage possible, and to act upon the results of such identification.
- We expect that all pupils with SEND will meet or exceed the high expectations set for them based on their age and starting points.
- We will develop a feeling of self-esteem within each pupil.
- We aim to foster an atmosphere in our school which promotes a happy, sensitive and secure environment to ensure the most effective learning for all children
- We aim to ensure that pupils with SEND receive a broad and balanced curriculum and join in all school activities as far as possible.
- We aim to provide for children's individual needs by supporting them in various ways whole class, small groups and individual.
- We will monitor closely those with SEND by review and assessment, to enable us to recognise, celebrate and record achievements
- Where possible, we will provide access to a range of resources to support staff in their teaching of children with SEND.
- We will the voice of the child in monitoring and reviewing Personal Learning Plans.
- We aim to encourage parents and carers as partners in the learning process for their pupils.
- We want all pupils to become confident individuals who will be able to make a successful transition to secondary school.
- We will work within the guidance provided in the SEND Code of Practice, 2014.
- We will provide support and advice for all staff working with pupils with special educational needs.

Objectives

- To identify and provide for pupils who have special educational needs and additional needs.
- To work within the guidance provided in the SEND Code of Practice 2015.
- To operate a "whole pupil, whole school" approach to the management and provision of support for Special Educational Needs.
- To provide a framework for the SENDCo, other school staff and the wider community.
- To provide support and advice for all staff working with SEND pupils.

Categories of Special Educational Needs and Disabilities (SEND)

SEND is divided into four types:

- 1. Communication and Interaction this includes children with speech and language delay, impairments or disorders, hearing impairment, and those who demonstrate features within the autistic spectrum.
- 2. Cognition and Learning this includes children who demonstrate features of moderate, severe or profound learning difficulties or specific learning difficulties such as dyslexia, dyscalculia, dysgraphia or dyspraxia.
- 3. Social, Mental and Emotional Health this includes children who may be withdrawn or isolated, disruptive or disturbing, hyperactive or lack concentration.
- 4. Sensory and/or Physical Needs this includes children with sensory, multisensory and physical difficulties.

Behavioural difficulties, persistent disruptive or withdrawn behaviours do not necessarily mean that a child or young person has SEND and do not automatically lead to a pupil being registered as having SEND.

Slow progress and low attainment do not necessarily mean that a child has SEND and do not automatically lead to a pupil being recorded as having SEND.

Identifying and assessing SEND for children or young people whose first language is not English requires particular care; difficulties related solely to limitations in English as an additional language are not SEND.

Disability

Many children and young people who have SEND may have a disability under the Equality Act 2010 – that is '...a physical or mental impairment which has a long-term and substantial adverse effect on their ability to carry out normal day-to-day activities'.

This definition provides a relatively low threshold and includes more children than many realise: 'long-term' is defined as a year or more and 'substantial' is defined as more than minor or trivial. This definition includes sensory impairments such as those affecting sight or hearing, and long-term health conditions such as asthma, diabetes, epilepsy and cancer.

Children and young people with such conditions do not necessarily have SEND, but there is a significant overlap between disabled children and young people and those with SEND. Where a disabled child or young person requires special educational provision, they will also be covered by the SEND definition.

As a school we observe two key duties:

- We do not directly or indirectly discriminate against, harass or victimise disabled children and young people.
- We make reasonable adjustments, including the provision of auxiliary aids and services, to
 ensure that disabled children and young people are not at a substantial disadvantage
 compared with their peers. This duty is anticipatory it requires thought to be given in
 advance to what disabled children and young people might require and what adjustments
 might need to be made to prevent that disadvantage.

A Graduated Approach to SEND Support

At Chalk Ridge Primary School, we adopt a high quality first teaching and learning approach, the key characteristics of which are:

- highly focused teaching with clear learning outcomes
- high demands of pupil involvement and engagement with their learning
- high levels of interaction for all pupils
- appropriate use of teacher questioning, modelling and explaining
- an emphasis on learning through dialogue, with regular opportunities for pupils to talk both individually and in groups
- an expectation that pupils will accept responsibility for their own learning and work independently
- regular use of encouragement and authentic praise to engage and motivate pupils.

Teachers are responsible and accountable for the progress and development of all the pupils in their class, including where pupils access support from Learning Support Assistants or specialist staff. High quality first teaching, scaffolded and varied for individual pupils, is the first step in responding to pupils who have or may have SEND; additional intervention and support cannot compensate for a lack of high quality first teaching.

We regularly and carefully review the quality of teaching for all pupils, including those at risk of underachievement, through lesson observations, work scrutiny, planning scrutiny, pupil conferencing and regular pupil progress meetings where pupil progress and attainment data is scrutinised. Professional development opportunities are provided for staff to extend their knowledge and understanding of SEND and high quality first teaching.

We assess each pupil's current skills and levels of attainment on entry, building on information from previous settings and key stages where appropriate. Class teachers, supported by the Senior Leadership Team, make regular assessments of progress for all pupils. These assessments seek to identify pupils making less than expected progress given their age and individual circumstances.

This can be characterised by progress which:

- is significantly slower than that of their peers starting from the same baseline
- fails to match or better the child's previous rate of progress
- fails to close the attainment gap between the child and their peers
- widens the attainment gap

The first response to such progress should be high quality first teaching targeted at a child's areas of weakness. This can also include progress in areas other than attainment – for instance where a pupil needs to make additional progress with wider development or social needs in order to make a successful transition to the next key stage or setting.

Where a pupil is identified as having SEND, we act to remove barriers to learning and put effective special educational provision in place. This SEND support takes the form of a four-part cycle through which earlier decisions and actions are revisited, refined and revised with a growing understanding of the pupil's needs and of strategies that support the pupil in making good progress and securing good outcomes. This is known as the graduated approach. It draws on more detailed approaches, more frequent review and more specialist expertise in successive cycles in order to match interventions to the SEND of children and young people.

Assess

In identifying a child as needing SEND support the class teacher, working with the SENDCo, carries out a clear analysis of the pupil's needs. This draws on the teacher's assessment and experience of the pupil, their previous progress and attainment, the views and experience of parents, the pupil's own views and, if relevant, advice from external support services. We take seriously any concerns raised by a parent. These are recorded and compared with our own assessment and information on how the pupil is developing. As part of this information gathering process the school uses the Hampshire criteria found at sen_support_guidance_for_schools_- for_web.pdf (openobjects.com)

In some cases, outside professionals from health or children's services may already be involved with the child. These professionals liaise with the school to help inform the assessments. Where professionals are not already working with school staff the SENDCo will contact them where necessary (with parental agreement).

Plan

Where it is decided to provide a pupil with SEND support, the parents are formally notified. The teacher and the SENDCo agree, in consultation with the parent and the pupil, the adjustments, interventions and support to be put in place, as well as the expected impact on progress, development or behaviour, along with a clear date for review. The support and intervention provided is selected to meet the outcomes identified for the pupil, based on reliable evidence of effectiveness, and are provided by staff with sufficient skills and knowledge. Where appropriate, plans seek parental involvement to reinforce or contribute to progress at home.

All teachers and support staff who work with the pupil are made aware of their needs, the outcomes sought, the support provided and any teaching strategies or approaches that are required.

Do

The class teacher remains responsible for working with the child on a daily basis. Where the interventions involve group or one-to-one teaching away from the main class or subject teacher, the teacher still retains responsibility for the pupil. They work closely with any Learning Support Assistants or specialist staff involved, to plan and assess the impact of support and interventions and how they can be linked to classroom teaching. The SENDCo supports the class teacher in the further assessment of the child's particular strengths and weaknesses, in problem solving and advising on the effective implementation of support.

Review

The effectiveness of the support and interventions and their impact on the pupil's progress are reviewed in line with the agreed date. The impact and quality of the support and interventions is evaluated, along with the views of the pupil and their parents. This feeds back into the analysis of the pupil's needs. The class teacher, working with the SENDCo, revises the support in light of the pupil's progress and development, deciding on any changes to the support and outcomes in consultation with the parent and pupil.

Where a pupil has an Education and Health Care Plan, the Local Authority, in liaison with the school, must review that plan at least every twelve months.

The success of the school's SEND policy and provision is evaluated through:

- monitoring of classroom practice by the Head Teacher, Deputy Head Teacher and SENDCo
- analysis of pupil tracking data
- monitoring of procedures and practice by the SEND governor
- Local Authority moderation process and OFSTED inspection arrangements
- meetings of parents and staff, both formal and informal.

Managing the needs of pupils on the SEND register

All children on the SEND Register have a Personal Learning Plan (PLP) or Personal Support Plan (PSP), which details important information about the child, including their areas of strength and weakness, their outcomes, steps taken to enable the child to achieve them and any other professionals who have contact with the child. Class teachers, parents, pupils and other professionals will all contribute to the PLP/PSP. It is designed to be a working document which is updated to reflect the current needs of the child. Review meetings will take place at least three times per year, where parents and pupils and staff are involved in reviewing progress and setting new outcomes. Class teachers are responsible for evidencing progress according to the outcomes described in the plan.

Class teachers are responsible for maintaining and updating PLPs/PSPs. These are then shared with everyone involved with the child, including parents, school staff and, where appropriate, external agencies. The SENDCo reviews all records provided by class teachers to ensure consistency across the school and appropriateness and quality of outcomes.

There are three levels of support for pupils with SEND:

• **Universal level** funding is provided on a per-learner basis for all those attending the school. This is also known as element 1 funding. Good quality universal provision will reduce the need for deployment of more expensive resources.

- Targeted level mainstream providers (schools and academies) are expected to contribute
 the first £6,000 of the additional educational support provision for learners with SEND from
 their notional SEN budget. This is also known as element 2 funding.
- **Specialist** or **personalised level** top-up funding above £10,000 (elements 1 and 2) is provided on a per-learner basis by the commissioner placing the pupil. It is important to note that the level and combinations of provision may change over time.

Specialist Support

We may involve specialists at any point to advise us on early identification of SEND and effective support and interventions. Where a pupil continues to make less than expected progress, despite evidence-based support and interventions that are matched to the pupil's area of need, we will consider involving specialists, including those secured by the school itself or from outside agencies.

The pupil's parents are involved in any decision to involve specialists. The involvement of specialists and what is discussed or agreed will be recorded and shared with the parents and teaching staff supporting the child in the same way as other SEND support.

Education, Health and Care Needs Assessments

Where, despite the school having taken relevant and purposeful action to identify, assess and meet the SEND of the child, the child has not made expected progress, the school or parents will consider support by requesting an Education, Health and Care needs assessment.

Criteria for exiting the SEND register

If it is felt that a child is making progress which is sustainable then they may be taken off of the SEND register. If this is the case then the views of the teacher, SENDCo, pupil and parents are taken into account as well as those of any other professionals involved with the child. If it is agreed by all to take the pupil off the SEND register, then all records will be kept in line with GDPR guidance (and necessary paperwork passed on to the next setting). The pupil will continue to be monitored through the school's monitoring procedures, such as pupil progress meetings. If it is felt that the pupil requires additional assistance, then the procedures set out in this policy will be followed.

Supporting pupils and families

Class teachers, in partnership with the SENDCo, are responsible for ensuring that pupils are able to access assessments carried out within their class. If a child's needs mean that they are unable to access standardised tests, then the SENDCo will liaise with the class teacher to assess pupils' eligibility for access arrangements.

Supporting pupils at school with medical conditions

The school recognises that pupils at school with medical conditions should be appropriately supported so that they have full access to education, including school trips and physical education. Some children with medical conditions may be disabled and where this is the case the school will comply with its duties under the Equality Act 2010. Some may also have Special Educational Needs and/or Disabilities (SEND) and may have an Education, Health and Care (EHCP) Plan which brings together health and social care needs, as well as their special educational provision. The SEND Code of Practice (2015) is followed. The school has a policy for Supporting Pupils at School With Medical Conditions, which can be found on the school website.

Training and resources

In order to maintain and develop the quality of teaching and provision to respond to the strengths and needs of all pupils, all staff are required to undertake training and development. Staff training needs are discussed at performance management meetings; both teaching and support staff will be made aware of training opportunities that relate to working with a child with SEND. The school's

SENDCo attends the regular Local Authority SEND update meetings in order to maintain awareness of local and national developments in SEND.

Roles and responsibilities

Provision for pupils with SEND is a matter for the school as a whole. The governing body, in consultation with the Head Teacher, has a legal responsibility for determining the policy and provision for pupils with Special Educational Needs and Disabilities. It maintains a general overview and has an appointed representative who takes particular interest in this aspect of the work of the school.

The SEND Governor will:

- Help to raise awareness of SEND issues at governor body meetings.
- Monitor the quality and effectiveness of SEND and disability provision within the school and update the governing body on this.
- Work with the Headteacher and SENDCo to determine the strategic development of the SEND policy and provision in the school.
- Ensure that the school SEN Information Report (see website) informs parents how the school is making sure it meets the learning needs of individual pupils
- Ensure that governors have regard to the requirements of the Code of Practice for Special Educational Needs (2014).

The Head Teacher is responsible for:

- the management of all aspects of the school's work, including provision for pupils with special educational needs
- keeping the governing body informed about SEND issues
- working closely with the SENDCo
- the deployment of all Special Educational Needs personnel within the school
- monitoring and reporting to governors about the implementation of the school's SEND policy and the effects of inclusion policies on the school as a whole.

The SENDCo is responsible for:

- overseeing the day-to-day operation of the school's SEND policy
- co-ordinating the provision for pupils with special educational needs
- ensuring that an agreed and consistent approach is adopted
- liaising with and advising other school staff
- helping staff to identify pupils with special educational needs
- carrying out assessments and observations of pupils with specific learning barriers
- supporting class teachers in devising strategies, drawing up Personal Learning Plans (PLPs), Personal Support Plans (PSPs), setting targets appropriate to the needs of the pupils, and advising on appropriate resources and materials for use with pupils with special educational needs and on the effective use of materials and personnel in the classroom
- liaising closely with parents of pupils with SEND alongside class teachers, so that they are aware of the strategies that are being used and are involved as partners in the process
- liaising with outside agencies, arranging meetings and providing a link between these agencies, class teachers and parents
- maintaining the school's SEND register and records
- assisting in the monitoring and evaluation of the progress of pupils with SEND through the use of existing pupil progress and attainment data
- · contributing to the in-service training of staff
- liaising with the SENDCOs in receiving schools and/or other primary schools to help provide a smooth transition from one school to the other

• taking part in Local Authority events and activities to support the work of the school.

Class teachers are responsible for:

- providing high quality first teaching for all children
- assessing pupils' needs and planning appropriate adjustments, interventions and support to match the outcomes identified for the pupil (in liaison with the SENDCo, parents and pupil)
- drawing up Personal Learning Plans (PLPs), Personal Support Plans (PSPs) and setting targets appropriate to the needs of the pupils
- regularly reviewing the impact of these adjustments, interventions and support, including pupils with SEND in the classroom, through providing an appropriately scaffolded and varied curriculum
- retaining responsibility for the child, including working with the child on a daily basis
- making themselves aware of the school's SEND policy and procedures for identification, monitoring and supporting pupils with SEND
- directly liaising with parents of children with SEND.

Learning Support Assistants should:

- be fully aware of the school's SEND policy and the procedures for identifying, assessing and making provision for pupils with SEND
- use the school's procedure for giving feedback to teachers about pupils' progress
- work as part of a team with the SENDCo and the teachers, supporting pupils' individual needs and ensuring inclusion of pupils with SEND within the class. They play an important role in implementing PLPs, PSPs and monitoring progress.

Storing and managing information

Written documents relating to pupils on the SEND register will be stored in the SENDCo's filing cabinet, which is locked overnight. SEND records will be passed on to a child's next setting when they leave Chalk Ridge Primary School. The school has a Confidentiality Policy which applies to all written and electronic pupil records.

Accessibility

The Disability Discrimination Act, as amended by the SEN and Disability Act 2001, places a duty on all schools to increase, over time, the accessibility of schools for disabled pupils and to implement their plans. Schools are required to produce written accessibility plans for their individual school and Local Authorities are under a duty to prepare accessibility strategies covering the maintained schools in their area. The school's Single Equality Scheme can be found on the website.
